Builders use cash sops to woo buyers, drive sales

“THESE ARE NOT subvention schemes but staggered payments to convert latent demand into sales, especially in the ready-to-move-in space,” Puri said. At its ready-to-move-in project in Esquire in the western suburbs of Goregaon, Oberoi Realty is allowing buyers to move into the new home with a 25% upfront payment; the remaining 75% is to be paid interest-free in equal installments of 15% over the next five years. At its under-construction

project in central suburb of Mulund, Oberoi is offering both bank and developer subvention schemes. Buyers can book a home for just 10% of the value and get stamp duty benefits.

Sunteck Realty has rolled out a 10-90 scheme at Sunteck World, Naigaon & Sunteck City, Goregaon. The apartments can be booked with a 10% down payment with the remaining 90% paid at the time of possession. The developer promises to complete the project in less than six months.

Godrej Properties was running a similar 10:90 scheme across projects. For the 10 days of Ganesh Chaturthi, the company ran 10 offers which included, inter alia, zero booking amount,

zero floor rise, zero EMI till March 2021 and zero interest on stamp duty for properties in Mumbai. Mumbai-based Wadhwa Developers is running a campaign called ‘postpaid’ homes across its projects in central suburbs of Mulund, Thane, Ghatkopar and western suburbs of Goregaon. The scheme allows the buyer to get ready possession and move in post a 10% payment and nil GST. Moreover, there’s a moratorium till July 2021.

The Hiranandani Group is guaranteeing rental income with capital appreciation on property investments in its 1BHK houses in the central suburb of Powai. The developer is promising ₹50,000 per month

rentals, with an annual escalation of 5%, against the overall cost of apartment priced at ₹1.49 crore all-inclusive. The assured rental scheme, it says, will earn an average return of 4.5% per annum; after tax, the net earning is 3.18% versus a fixed deposit post-tax return of 3.05%. Meanwhile, in a concerted effort, more than 600 developers of Mumbai Metropolitan Region, Pune and Nashik holding over 1,000 projects have decided to bear the stamp duty on residential property bought till October 31, 2020. Home sales crashed to decadal lows between January and June 2020 with new

launches falling 46% year-on-year to 60,489 units. Unsold inventory in June was 4.46 lakh units, virtually unchanged from levels in June 2019.

Solar power: Bundling to cushion tariff hit to consumers

THE 3 GW CAPACITY to be combined with other projects is part of the 12 GW projects awarded in the maiden auction under the

manufacturing-linked scheme. Adani Green Energy will build 8 GW generation capacity and Azure Power will develop 4 GW and supply power at ₹2.92 per unit, under the scheme. As part of the deal, the two companies will also build 3 GW of solar equipment manufacturing capacities in the country (Adani 2 GW and Azure 1 GW).

The winners of the February auctions for 1.2 GW were Soft-Bank Group’s SB Energy, Canadian energy firm AMP Energy’s India unit, New York-based Eden Renewables’ Indian arm and ReNew Power. In the June auction of 2 GW — where the all-

time low tariff of ₹2.36 per unit was discovered — the winners were Spanish firm Solarpack’s Indian arm, Avikiran Surya (backed by Italian utility Enel), Eden Renewables, a subsidiary of Germany’s Ib Vogt, UK’s CDC-backed Ayana Renewable, Amp Energy Green and ReNew Power.

As FE recently reported, several adversities, including reluctance of discoms to sign power supply agreements (PSAs) with solar projects, are threatening to disrupt the country’s solar power progress. Around 6 GW of stand-alone renewable power projects, won by various players after quoting the lowest rates in

reverse auctions conducted by Seci, are staring at an uncertain future as the agency has not yet found buyers for electricity from these solar/wind power generation units. Another 1.7 GW projects have sought to terminate their power purchase agreements, frustrated by delays caused by other parties. While a section of the industry has blamed discoms for not signing PSAs in the hope of better deals in the future, experts have also pointed out that Seci has conducted many auctions without assessing the states’ appetite for such unreliable and intermittent sources of power.

# संपादकीय

## कंगना आणि शिवसेना

कंगना रनौत आणि शिवसेना यांच्यात मुंबईवरून चांगलीच जुंपली आहे. किंबहुना, जाणिवपूर्वक शिवसेना या फालतू वादात उतरली आहे. याचे एकमेव कारण म्हणजे कोरोना संकटाशी मुकाबला करण्यात सेनेला प्रचंड अपयश आले आहे. कुठूनच काही दिलासा देणारी बातमी येत नाही. लोक हताश झाले आहेत आणि हळूहळू त्यांचा संताप आता शिवसेनेच्या विरोधात एकवटतो आहे. सेनेला याची चांगली कल्पना आली आहे. म्हणून कंगनाच्या वक्तव्याचे भांडवल करून उगीचच आगखाऊ भाषणे ठोकली जात आहेत. कोरोनावरून लक्ष अन्यत्र वळवण्याचा सेनेचा हा प्रयत्न आहे. आणि मुंबईविरोधात कंगनाने वक्तव्य केले तर एकट्या शिवसेनेलाच इतका राग का यावा, हा सवालही उपस्थित होतोच. काँग्रेस आणि राष्ट्रवादी हेही पक्ष सरकारमध्ये सामिल आहेत. त्यांच्या नेत्यांनी उगीचच जाता जाता पिक टाकावी, तशी वक्तव्ये करून या प्रकाराला झटकून टाकले आहे. याचे कारण उद्या महाविकास आघाडी सरकार कोरोना रोखण्यात आलेल्या अपयशामुळे सत्तेतून पायउतार झालेच तर त्याचा दोष काँग्रेस आणि राष्ट्रवादीला फारसा लागणार नाही. म्हणूनच ते आगलावी वक्तव्ये करण्यापासून दूर पळत आहेत. शिवसेना मात्र जाणिवपूर्वक स्वतःला मुंबईचा आपणच कैवारी असल्यासारखी दाखवण्याचा प्रयत्न करत आहे. परंतु यात आश्चर्य काहीच नाही. शिवसेनेचे अवघे राजकारणच कायम भावनिक मुद्यांभोवती राहिले आहे. मुळात सेनेची स्थापनाच भावनिक मुद्यावर झाली. मराठी माणसाचा मुद्दा घेऊन सेना आली खरी, पण एकट्या मराठी अस्मितेच्या नावावर सत्ता मिळणार नाही, हे लवकरच सेनेच्या लक्षात आले. मग मराठीच्या जोडीला हिंदुत्वाचा मुद्दा घेतला. पण हिंदुत्वाच्या मतपेढीवर अगोदरच भाजप किंवा जनसंघाचा कब्जा होताच. त्यामुळे हिंदू मतपेढीत वाटेकरी होणे सेनेने पसंत केले. सांगायचा मुद्दा हा की, सेनेचे सारे राजकारण भावनिक मुद्यांवर राहिले आहे. बुनियादी प्रश्नांना सेनेने कधी हात घातला नाही आणि त्यांच्या नेत्यांनी ती कुवतही नव्हती. त्यामुळे मग मुंबईला महाराष्ट्रापासून तोडण्याचा डाव वगैरे पिल्लू शिवसेनावाले उगीचच सोडून घ्यायचे. ज्या काँग्रेसवर शिवसेनेने असे आरोप नेहमीच केले आहेत, त्या काँग्रेसबरोबर आज सत्ता उपभोगतानाही सेनेला काही वाटत नाही. सेनेचे लाचार भाट पत्रकार मुख्यमंत्री आणि सेनेचे गोडवे गात असले तरीही परिस्थिती लोकांना माहित आहे. पत्रकारांची मते वाचून लोक आपली मते ठरवत आहेत. त्यामुळे शिवसेनेला आता भावनिक मुद्यांची गरज वाटत होतीच. कंगनाने त्यांना नेमकी ती संधी दिली. कंगनाचे वक्तव्य खरेतर सेनेसाठी इष्टापत्तीच ठरली आहे. परंतु आता लोक हुषार झाले आहेत. असल्या बालिश युक्त्यांना ते बळी पडत नाहीत. आताच्या पिढीला मुंबईवगैरेशी काही देणेघेणे नाही. म्हणूनच तर शिवसेनेचा मताधार ढासळत चालला आहे. पण तिकडे लक्ष देण्याऐवजी केवळ कंगना रनौतसारख्या मुद्यांवर वातावरण तापवण्याची गोष्ट केली जात आहे. वास्तविक, सेनेवर कितीतरी जहाल टिका कोरोना काळात अनेकांनी केली आहे. परंतु त्यात भावनिक मुद्दा नसल्याने ती निमूटपणे ऐकून घेतली. कंगनाच्या वक्तव्यावर इतका थथथयाट करणार्या सेनेला वास्तविक महिलेचा अपमान करणे शोभत नाही. आमदार प्रताप सनगाई यांनी तर कंगनावर हल्ला करण्याची धमकी दिली आहे. आमदाराने या पातळीवर उतरणे हे काही योग्य नाही. मग तो कोणत्याही पक्षाचा असो. मूळ प्रश्नांवरून लक्ष वळवण्याचा हा डाव आहे, हे सहज लक्षात येते. सुशांत राजपूत मृत्युप्रकरणी आता इरगचा मुद्दाही आला आहे. हे प्रकरण आता गंभीर होत चालले आहे. शिवसेना या प्रकारात घेत गुंतली नसेलही. परंतु शिवसेनेने सीबीआय चौकशीला विरोध करून तसेच वारंवार रिया चक्रवर्तीची बाजू घेऊन या प्रकरणात गोत्यात आली आहे, हे निश्चित आहे. मुख्यमंत्र्याला अडचणीत आणण्याची ही कुणाची चाल आहे, यातील सत्य यथावकाश बाहेर येईलच. शिवसेनेने हे प्रकरण इतके अंगावर घेण्याची काहीच गरज नव्हती. मुंबईचा मुद्दा हा आता मते मिळवून देणारा राहिलेला नाही, हे शिवसेना जितक्या लवकर लक्षात घेईल तितके बरे. कारण या मुद्यात आता दम उरलेला नाही, हे सेना सोडून सर्वांच्या लक्षात आले आहे. आणि मुंबईसाठी शिवसेना आणि मनसे जरी इतके लढण्याचा आव आणत असले तरीही मराठी माणूस मुंबईत आहे कुठे, हे त्यांना विचारावे लागेल. महापालिका निवडणुकीत भाजपने जवळपास शिवसेनेच्या बरोबरीने जागा मिळवल्या होत्या, हे काय सांगते. परंतु शिवसेनेने ही सावध चाल खेळली आहे. कंगना रनौत ही काही शिवसेनेचे लक्ष्य नाही. दोन वर्षांनी मुंबई महापालिका निवडणुका होत आहेत. त्यावेळी आपला मुंबईचा अजेंडा पक्का करण्यासाठी ही शिवसेनेची खेळी आहे. नाहिर असे कितीतरी सेलेब्रिटी मुंबईबद्दल वाट्टेल ते बोलून गेले आहेत. त्यांचा शिवसेनेने साधा निषेधही केला नाही. नसिरुद्दीन शहा, आमिरखान यांनीही मुंबईत भीती वाटत असल्याचे म्हटले होते. तेव्हा शिवसेनेने मौन पाळले होते. याचा अर्थ असा की विषय कंगनाचा नाहीच. विषय प्रत्येक पक्ष आपापल्या सोयीनुसार तिच्या भोवती राजकारण खेळतो आहे. एखाद्या सेलेब्रिटीचे विधान राजकारणाचा विषय व्हावे, हाच महाराष्ट्राचा पराभव आहे.

गुरु आपल्या शिष्याची परीक्षाच्या स्मात गुरु दक्षिणा देखील मागून घेतात. कित्येकदा गुरु दक्षिणेत शिष्याने गुरूना तेच दिले जे त्यांनी मागितले. गुरूंच्या आज्ञेचे पालन करणं शिष्याच्या जीवनाचे कर्तव्य असतात आणि कित्येकदा तर हे त्यांचा जीवन आणि मृत्यू प्रश्न देखील बनतात. गुरु दक्षिणा हे गुरूबद्दलचे आदर आणि समर्पणाचे भाव आहे. गुरूच्या बदलची खरी दक्षिणा हीच आहे की गुरुची इच्छा असते की त्यांचा शिष्याने आता गुरु व्हावं. मूळतः गुरु दक्षिणेचा अर्थ शिष्याच्या परीक्षेच्या संदर्भात घेतात. गुरुदक्षिणा त्या वेळी देतात किंवा गुरु घेतात ज्यावेळी शिष्यामधे पूर्णता येते. म्हणजे ज्यावेळी शिष्य गुरु होण्याचा मार्गावर असतो. गुरु कडील सर्व ज्ञान शिष्य ग्रहण करतो आणि आता गुरु कडे त्याला देण्यासाठी काहीच शिल्लक नसतं तेव्हा गुरुदक्षिणा अर्धपूर्ण होते.

अर्जुन आणि द्रोणाचार्य : द्रोणाचार्याला रणांगणावर जेव्हा अर्जुनाने आपल्या समोर एका प्रतिस्पर्धीच्या स्मात बघितल्यावर त्यांनी लढण्यास नकार दिला. हे अर्जुनाच्या शिष्याच्या स्मात द्रोणाचार्यासाठी प्रेम आणि आदराची भावना होती. एकलव्याची गुरुदक्षिणा : त्याच प्रकारे जेव्हा एकलव्याशी गुरु द्रोणाचार्याने प्रश्न केले की आपले गुरु कोण आहे, तेव्हा त्याने उत्तर दिले - गुरुदेव आपणच माझे गुरु आहात आणि आपल्या वक्तव्याने आपल्या मूर्तीला मी गुरु

एकलव्य म्हणे - गुरुदेव आपण आज्ञा करा मी गुरु दक्षिणा देण्यास तयार आहे. तेव्हा गुरु द्रोणाचार्याने एकलव्याच्या उजव्या हाताचा अंगठा मागितला. एकलव्याने आनंदाने आपला अंगठा कापून गुरूच्या चरणी अर्पित केला. हे केल्याने एकलव्याचे काहीही नुकसान झाले नाही पण त्याची कीर्ती सर्वत्र पसरली आणि एकलव्य एक ऐतिहासिक पुरुष झाला. गुरुचे प्रेम दिसायला कठीर असले तरी ही ते आपल्या शिष्याला इजा होऊ देत नाही. गुरुचे सारे जीवन आपल्या शिष्याला योग्य बनविण्यात लावतात, तर दुसरे कर्तव्य आहे शिष्याचं आणि ते आहे गुरु दक्षिणा देण्याचं. विवेकानंद आणि शिवाजी महाराजांची गुरु दक्षिणा : विवेकानंद यांनी आपल्या गुरूच्या आदेशानुसार संपूर्ण जगात सनातन धर्माचा प्रचार केला. छत्रपती शिवाजी आपल्या गुरूच्या आदेशानुसार सिंहनेचे दूध काढून घेऊन आले होते आणि गुरुदक्षिणा म्हणून अवघ्या महाराष्ट्राला जिंकून आपल्या गुरूच्या चरणी ठेवले होते. कृष्ण व बलदेव यांची गुरु दक्षिणा : कृष्ण आणि बलदेव यांनी सांदिपनी आश्रमात काहीच महिन्यात सर्व प्रकाराची शिक्षा ग्रहण केली होती. तत्पश्चात गुरु दक्षिणा देण्याची वेळ आली होती. गुरूने कृष्णाला त्यांचा मुलास आणून देण्याचे सांगितले ज्याला काही दिवसांपूर्वी मगर गिळून गेला होता. कृष्णाने आपल्या गुरूस त्याचा मुलासाठी दुखी बघून त्यांचा मुलाला आणून देण्याची प्रतिज्ञा घेतली आणि कृष्ण आणि बलराजाने यमपुरात जाऊन यमराज कडून त्याचा मुलाला वापस आणून दिले. अंगुलीमान डाकू : हे देखील बुद्धाचे प्रभाव होते की अंगुलीमान सारखा दरोडेखोर देखील संन्यासी बनला. असेच असतात गुरुचे सामर्थ्य. ज्या प्रमाणे चाणक्याने चंद्रगुप्त मौर्याला, समर्थ राम दासाने छत्रपती शिवाजींचा आणि रामकृष्ण परमहंसाने विवेकानंदांना शोधले होते त्याच प्रकारे जर आपण योग्य शिष्य असल्यास आपल्याला गुरु शोधण्याची गरजच नाही.
