- 2. Notice of the Postal Ballot.
 - 2.1. The Company had hosted the Notice of Postal ballot on its website and the website of NSDL (e-voting Agency), BSE and MSEI on 17th May 2023.
 - 2.2. Pursuant to the MCA circulars, Notice was published on 18th May 2023 in Mumbai Lakshdeep (in Marathi Language) (Mumbai Edition), and Financial Express (In English Language) (Mumbai Edition).
 - 2.3. The Company has informed that, on the basis of the Register of Members and the List of Beneficial Owners made available by the Depositories viz., National Securities Depository Limited (NSDL) and Central Depository Services (India) Limited (CDSL), as on 12th day, of May 2023 ("the cut-off date"), the Company has completed sending of Postal Ballot Notice through E-Mail on 17th May 2023 to 1,370 Members who had registered their email-IDs with the Company / Depositories.
